### 檢體要求 Requirement of Sample:

- 1. 檢測須至少 1 ml 血清 Minimal required serum volume for testing is 1 ml.
- 2. 血清檢體應標識動物品種及晶片號碼 Each sample shall be labeled with the animal's species and microchip number.
- 3. 三層包裝且最外層包裝應堅固,檢體容器應可防洩漏,如發生破損不予檢測;國際運輸包裝需符合 IATA 650 指示 The packaging shall consist of three components and the outer packaging shall be rigid. The primary receptacle(s) shall be leak proof and the sample will not be test if broken. International shipping should be packed in compliance with IATA packing instructions 650.
- 4. 血清顏色應呈透明黃色,溶血或混濁血清易有細胞毒性而影響檢測 The color of serum shall be transparent yellow. Hemolytic or cloudy serum may cause cytotoxic effect and affect the results of test.
